

GIFT AID DECLARATION

If you pay UK income tax or capital gains tax and have not already completed a gift aid declaration in favour of The Friends of Guildford House, please read and complete the declaration overleaf and return it with your Membership Application.

Please note:

1. You can cancel this declaration at any time by notifying The Friends of Guildford House.
2. You must pay an amount of UK income tax and / or capital gains tax at least equal to the tax that The Friends of Guildford House reclaims on your donations or subscriptions in the tax year (currently 25p for each £1 you give).
3. If in the future your circumstances change and you no longer pay tax on your income and capital gains equal to the tax that The Friends of Guildford House reclaims, you should cancel your declaration (see note 1).
4. If you pay at the higher rate you can claim further tax relief in your Self Assessment tax return.
5. If you are unsure whether your donations/subscriptions qualify for Gift Aid tax relief, ask The Friends of Guildford House. Or ask your local tax office for leaflet IR65.
6. Please notify The Friends of Guildford House if you change your name or address.

VISITS

Visits during the summer to historic houses, gardens and other galleries and museums.
Winter visits to exhibitions and other events in London and southern England.

LECTURES

Six illustrated lectures are arranged in the autumn and winter months. Usually held in the 17th-century Guildhall in the High Street, these are designed to complement our programme of visits and Guildford House exhibitions. We invite well-known speakers in the field of fine arts to broaden our appreciation of forthcoming events.

GUILDFORD HOUSE

The house is an extremely rare example of a Restoration town house – described as “a spirited work of 1660” by Simon Jenkins in *England's Thousand Best Houses*. Its beautiful carved staircase, finely decorated plaster ceilings, pretty oriel window, original casement windows with their exquisite fittings, and attractive courtyard make it a jewel of the High Street.

As well as being an architectural gem, it is a well-used and well-loved art gallery.
